

Dear Members of the FIPS Mouche,

Let us invite you on behalf of all members of the South Bohemian Board of the Czech Anglers Union and of the Organisation Committee to the 3rd World Ladies Fly Fishing Championship and 9th World Masters Fly Fishing Championship, to be held in South Bohemia, Czech Republic, from May 19 till May 25, 2024.

We have prepared a special web-site <u>www.ffch.cz</u> where you can find all important information as well as the latest news and the programme of the Championship. Let us highlight the most important points.

Important dates

Final registration by January 31, 2024

Payment by February 29, 2024

Fees

The headquarter of the championship will be located in Sport Hotel Zátoň, second hotel is Penzion Herbertov. The fees depend on the type of accommodation. The basic fee was calculated for two persons in a double room. In the case of single rooms, we have to ask for extra payment. Both hotels also offer extra beds on large sofa beds and we offer also this possibility for slightly lower price. If the capacity of both hotels will be filled, the third hotel will be Hotel Růže in Rožmberk.

Fees include 6 nights, full day board meal (starts from lunch on Saturday May 19, 2024) and two banquets. Fees for members of teams also includes Czech state rod licence and fishing permit valid for competition venues during the Championship.

Registration

Registration will be processed in two steps:

- 1) We would like to ask you to send us the completed registration form by e-mail to hladik@jcus.cz. Registration form will be published on website. The registration will be based on the rule first registered-first chooses according to the available capacity of the hotels.
- 2) We will book rooms for you according to your requests, we will calculate your fee and will send you an invoice.

Fishing licences

To arrange the Czech state rod licences and fishing permits, we need to receive by e-mail a completed application form for every attendant and a copy of ID card or passport by the end of February 2024. The application form will be published on the website.

For any practice before the Championship, it is necessary to buy fishing permits, all details can be found on the website, we can help to arrange it.

Rules modifications will be published on the website and will be explained during the Captains' meeting.

Competition venues

Description of all the venues including maps and pictures will be found on the website.

Practice

The fishing in competition sectors by competitors or their agents is prohibited during a period of thirty days prior to the official start of the event (from April 19, 2024) with one exception. The practice on Květoňov lake will be extended until May 4, when the last local competition will be held on the lake. Any attendant of the Championship is eligible to participate in the event.

Practice waters for all venues will be published on the website.
