## Treasurers report Financial Year 2022.

### **Preliminary remarks**

FY runs from 01/01/2022 to 31/12/2022

Control was performed by the Board of Auditors on the 3 Feb 2023 in Rome . Signed report dates 27-02-2023 by Victor Otal, Teodor Bentu and Marco Tamietto.

2022 was a year of "back to business as usual" as we staged 5 championships : the Worlds in SPA and 4 combined 2 by 2 (Euro + Ladies NOR , Masters + Youth ITA).

The figures are shown in the table in annex A. Annex B provides a 5 year overview.

#### Income

Registration fees for all 5 championship have been received for a total amount of 12.175 Euro.

We received also 10.000 \$ by Cortland Company as sponsorship for the youth championship. The money was used completely for the 2022 championship as we had 10 teams taking part.

The income figure for Masters championship influenced by the significant number of registered guests.

Regarding the CIPS figure please note that this figure contains the debt of 4700 Euro from 2021. The actual CIPS contribution for 2022 is thus 14700 €.

#### **Expenditure**

Cost related to the championships are mainly due to travel to and from the host countries plus the travel fee for the international supervisors. This cost amounted to 5104.50 Euros ( 300 euro per member + some bank fees )

For the combined championships the figures are calculated to a ratio of the participating teams / competitors.

Please note some expenses of Y+2 inspections .

Substantial upgrading and development of our website resulted in a total cost of approximately 3000 euro.

The acquisition of Polo's and Caps for FIPS-Mouche Board and IS team amounted to quite a substantial figure. These clothing items were distributed to IS members, stock is still available.
