Rules and Rules modifications



Know the rules !

- Go thru the rules modifications (RM) of the championship on FM website
- Controllers and captain can enter island and back if competitor asks (agreed on June by FIPS Mouche and IO)
- All fish species eligible, size limit 20 cm

Minor deviations accepted unanimously during the CM

- controllers can help to carry equipment (proposal from organizers)
- competition time from on sectors III, IV, V from Tuesday on, might be changed to avoid collisions with canoes (will be announced by organizers on website, infoboard WhatsApp on Monday in the afternoon, after lessons learnt from 1.day)
- Due to security reasons controllers will be placed:
 - on the right bank side on sector I..IV, except for Sector III : beats 2,3
 - on the left bank side on sector V, except for the following beats 2,3,9,10
